

HUD Perspective

Discharge Planning

- 42 USC Sec. 11362
Discharge Coordination Code ...any governmental entity serving as an applicant must agree to develop and implement, to the **maximum** extent practical and where appropriate, policies and protocols for the discharge of persons from publicly funded institutions or systems of care (such as health care facilities, foster care or other youth facilities, or correction programs and institutions) in order to prevent such discharge from immediately resulting in homelessness for such persons.
- Governmental Entity- State and local governments, entitlement communities, territories, and any governmental entity applying for McKinney-Vento funds

Requirements for CoCs & Grantees

- Any Continuum applying for funds required to work with appropriate governmental entity to develop discharge policies
 - Evidence of such partnership includes memorandum of understanding, written commitments or other such documentation
- CoC receives points for progress on discharge planning as part of their overall Continuum Process and Strategy.

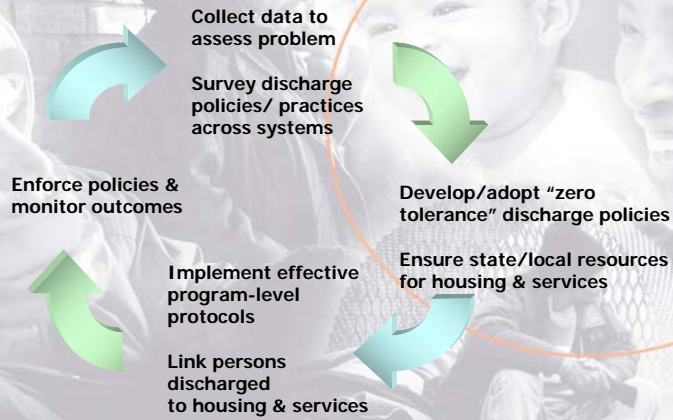
- Emphasis on integration of CoC Plans with other plans including state/local 10-year plans, the Consolidated Plan, and institutional discharge plans.

- *All public agencies will develop “zero tolerance” policies and procedures to assure that none of their consumers exit to a homeless shelter or the street.*
